Removal of agents from list of branded agents classified as generics

Effective May 1, 2016, the following agents will be removed from the list of branded agents classified as generics meaning that they will now count as a brand toward members' monthly prescription limits and copays. **Any requests for these brand name agents will require a new prior authorization effective May 1, 2016.**

- RITALIN LA^{PA≥21, QL}

In order to facilitate transition to the generic products, the following generic products will pay at point of sale for patients with existing prior authorizations effective April 1, 2016. Please transition your patients to the generic products as soon as possible to allow minimal disruption for the patient and avoid unnecessary delays at the pharmacy.

- methylphenidate ER^{PA≥21, QL}

Addition of Quantity Limits

Effective May 1, 2016, quantity limits will be implemented for the following agents:

- Lovenox[®]/enoxaparin 30 mg/0.3 mL: 0.6 mL per day
- Lovenox[®]/enoxaparin 60 mg/0.6 mL: 1.2 mL per day
- Lovenox[®]/enoxaparin 80 mg/0.8 mL, 120 mg/ 0.8 mL: 1.6 mL per day
- Lovenox[®]/enoxaparin 100 mg/ mL, 150 mg/mL: 2 mL per day
- Lovenox[®]/enoxaparin 40 mg/0.4 mL: 0.4 mL per day
- Stribild[®]: 1 per day
- Renvela[®]/sevelamer carbonate 800 mg tablets, 0.8 gm powder packets: 6 per day
- Renvela[®]/sevelamer 2.4 gm powder packets: 5 per day
- Mephyton[®]/phytonadione 5 mg tablet: 5 per prescription
- Arixtra[®]/fondaparinux 2.5 mg/0.5 mL: 0.5 mL per day
- Arixtra[®]/fondaparinux 10 mg/0.8 mL: 0.8 mL per day
- Arixtra[®]/fondaparinux 5 mg/0.4 mL: 0.4 mL per day
- Arixtra[®]/fondaparinux 7.5 mg/0.6 mL: 0.6 mL per day
- Lonsurf[®]: 8 per day
- Jakafi[®]: 2 per day

<p>Titration Dose Override for the following select drugs/drug classes: oral oncology agents, anticonvulsants, warfarin, low molecular weight heparins, theophylline, Selective Serotonin Reuptake Inhibitors (SSRIs), Selective Norepinephrine Reuptake Inhibitors (SNRIs), atypical antipsychotics (except clozapine/Clozaril®), Hizentra®, Vivaglobin® - process second Rx for the same drug within 21 days of initial Rx with an override code to avoid the second Rx counting as another prescription against the limit.</p>	<p>Submission Clarification Code (D.0 42Ø-DK)</p>	<p>2</p>
<p>Titration Dose Override for the following select drugs/drug classes: clozapine/Clozaril®, Suboxone®, Zubsolv® and buprenorphine- will allow up to five prescription fills to process for the same drug within a month of the initial prescription without the subsequent fills counting against the enrollee's monthly RX limit.</p>	<p>Submission Clarification Code (D.0 42Ø-DK)</p>	<p>6</p>
